RESOLUTION OF INTENTION TO VACATE ALL THAT CERTAIN PORTION OF THE PUBLIC RIGHT KNOWN AS SECOND STREET LYING EAST OF THE EASTERLY RIGHT-OF-WAY LINE OF RUSSIAN RIVER AVE, AS DEDICATED ON THE MAP OF MESA GRANDE FILED IN BOOK 15 OF MAPS, PAGE 8, SONOMA COUNTY RECORDS AND AS ACCEPTED BY THE SONOMA COUNTY BOARD OF SUPERVISORS ON MAY 4, 1903, PURSUANT TO THE STREETS AND HIGHWAYS CODE SECTION 8300 ET SEQ (FIFTH SUPERVISORIAL DISTRICT)

The Board of Supervisors of Sonoma County resolves as follows, as required by Streets and Highways Code Sec. 8320 et seq:

1. The Board declares its intention to vacate all that certain portion of the public right-of-way known as Second Street lying east of the easterly right-of-way line of Russian River Avenue, as dedicated on the Map of Mesa Grande filed in Book 15 of Maps, Page 8, Sonoma County Records and as accepted by the Sonoma County Board of Supervisors on May 4, 1903.
2. The general location and extent of the right-of-way to be vacated is more specifically described in the legal description, "Exhibit A," and shown on the location map, "Exhibit B." For further information, or to view the exhibits, please contact the County Surveyor, Gary O'Connor, with the Sonoma County Permit and Resource Management Department at (707) 565-3711.
3. This vacation proceeding is conducted under Chapter 3 of Part 3 of Division 9 of the Streets and Highways Code (Sec. 8320 et seq).
4. The date, hour, and place for hearing all persons interested in the proposed vacation, which must not be less than 15 days after the adoption of this resolution, is set for:
