Background:

Bob has worked for the County of Sonoma as a permanent employee since 1983. His retirement was effective February 9, 2009, after having served the County for over 29 years.

Bob joined the County as a summer worker in the Healdsburg Road yard in 1980. He became a permanent Maintenance Worker I in April 1983.

Bob transferred to the Traffic Maintenance Crew in 1985 where he served the traveling public by diligently helping maintain the various roadway guidance and safety features – striping, pavement markings, and signs. The last ten years or so Bob has been helping protect the public by being charged with replacing and repairing the Department’s 17,000 signs as needed, often reporting to work on evenings and weekends to respond to emergencies.
