CONCURRENT RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SONOMA, THE BOARD OF DIRECTORS OF THE SONOMA COUNTY WATER AGENCY, THE BOARD OF COMMISSIONERS OF THE COMMUNITY DEVELOPMENT COMMISSION, AND THE BOARD OF DIRECTORS OF THE NORTHERN SONOMA COUNTY AIR POLLUTION CONTROL DISTRICT, AMENDING SALARY RESOLUTION NO. 95-0926, ADMINISTRATIVE MANAGEMENT, ADOPTING THE NEW JOB CLASSIFICATION AND ESTABLISHING THE SALARY FOR MARINA MANAGER, EFFECTIVE MAY 5, 2009.

WHEREAS, on September 25, 2007, the Board of Supervisors approved a strategic plan and reorganization request by Regional Parks proposing the creation of a new division within the department for Marina operations which includes the Sports Fishing Center located at Porto Bodega and the Spud Point Marina; and

WHEREAS, Regional Parks proposed under this strategic plan, the creation of a Marina Manager position to oversee Marina operations; and

WHEREAS, at their April 2, 2009 meeting, the County Civil Service Commission adopted the new class specification for Marina Manager; and

WHEREAS, the Human Resources Director has determined that the new classification of Marina Manager will be assigned to the Administrative Management Unit #0050; and

WHEREAS, Marina Manager is an exempt classification in accordance with the Fair Labor Standards Act; and

WHEREAS, the Human Resources Director and County Administrator recommend establishing the salary for the new classification of Marina Manager at salary range 3894.

NOW, THEREFORE BE IT RESOLVED, that the Board hereby establishes the new job classification and salary of Marina Manager and authorizes the amendment to Salary Resolution 95-0926, as described in Attachment A, which is attached and incorporated by reference hereto.
