RESOLUTION OF THE BOARD OF SUPERVISORS, COUNTY OF SONOMA, STATE OF CALIFORNIA, RECOGNIZING A DOUGLAS FIR TREE IN SONOMA COUNTY AS A HERITAGE OR LANDMARK TREE, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO SIGN THE SONOMA COUNTY HERITAGE TREE CERTIFICATE, DIRECTING THE DIRECTOR OF THE PERMIT AND RESOURCE MANAGEMENT DEPARTMENT TO EXECUTE A NOTICE OF HERITAGE OR LANDMARK TREE DESIGNATION AND DIRECTING THE COUNTY RECORDER TO RECORD THE DOCUMENT WITH NO FEE FOR PROPERTY LOCATED AT 20889 GEYSERVILLE AVE., GEYSERVILLE; APN 140-100-071.

WHEREAS, the property owner, [REDACTED] filed an application with the Sonoma County Permit and Resource Management Department to nominate a Douglas fir tree for a Heritage or Landmark Tree Designation located at 20889 Geyserville Ave., Geyserville; Supervisorial District No. 4; and

WHEREAS, the Board of Supervisors has adopted the Heritage or Landmark Tree Ordinance (Ordinance No. 3651) which established a method to recognize and protect certain trees in Sonoma County; and

WHEREAS, the tree has been evaluated and determined to be unique in terms of size, shape, and age; and

WHEREAS, a Heritage Tree Certificate has been prepared to recognize the tree; and

WHEREAS, a Notice of Heritage or Landmark Tree Designation has been prepared to be recorded to alert future property owners that the tree is protected by Ordinance No. 3651.

NOW, THEREFORE BE IT RESOLVED that the Sonoma County Board of Supervisors hereby authorizes the Chair to sign the Certificate, directs the Permit and Resource Management Department Director to execute the Notice for the Heritage Trees, and directs the County Recorder to record the document with no fees.

BE IT FURTHER RESOLVED that the Board of Supervisors designates the Clerk of the Board as the custodian of the documents and other material which constitute the record of proceedings upon which the decision herein is based. These documents may be found at the office of the Clerk of the Board, 575 Administration Drive, Room 100-A, Santa Rosa, California 95403.
