RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SONOMA,
STATE OF CALIFORNIA, APPOINTING ONE NEW MEMBER TO THE SONOMA COUNTY
COMMISSION ON AIDS/HIV HEALTH SERVICES PLANNING COUNCIL.

WHEREAS, the Sonoma County Commission on AIDS is designated as the Sonoma County HIV Health Services Planning Council for the purpose of receiving and administering funds under the federal Ryan White Treatment Modernization Act of 2006; and

WHEREAS, Federal and state guidelines recommend the Commission consist of a diverse membership including representatives of currently funded community-based AIDS service organizations and social service providers, including providers of housing and homeless services; the affected community, including individuals with HIV disease; the local public health agency; and State government; and

WHEREAS, consistent with the Commission's procedure for appointing members, the Membership Committee evaluates the applications and makes recommendations to the Commission, and the Commission is now forwarding the names to the Board for appointment for the term July 2009 through December 2010.
