RESOLUTION OF THE BOARD OF SUPERVISORS, COUNTY OF SONOMA, AUTHORIZING THE DISTRICT ATTORNEY TO ACCEPT A GRANT FROM THE CALIFORNIA ENDOWMENT FOR THE PURPOSE OF ESTABLISHING A FAMILY JUSTICE CENTER IN SONOMA COUNTY

WHEREAS, on October 21, 2008, the District Attorney, on behalf of a broad group of stakeholders representing law enforcement, county and community based organizations, presented a feasibility study to the Board of Supervisors outlining the benefits to our community of establishing a Sonoma County Family Justice Center; and

WHEREAS, the Board authorized the District Attorney and stakeholders to begin fundraising and strategic planning for the Sonoma County Family Justice Center; and

WHEREAS, the Board authorized the District Attorney to apply for a grant from the California Endowment for the purpose of establishing a Sonoma County Family Justice Center; and

WHEREAS, the California Endowment granted the District Attorney an award in the amount of \$300,000 toward establishing a Family Justice Center, with \$207,079 of this grant payable in May 2009, and the remaining amount of \$92,921 payable on June 30, 2010;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Sonoma authorizes the District Attorney to accept a grant from the California Endowment for the purpose of establishing a Family Justice Center in Sonoma County.
