Background:

The Board of Supervisors is requested to approve a resolution that authorizes the Director of Human Services to sign an agreement with the California Department of Aging (CDA). A copy of the contract is on file with the Clerk of the Board.

MI-0910-27: This agreement contains funding for the Area Agency on Aging and Senior Advocacy Services, Health Insurance Counseling and Advocacy Program (HICAP), to expand beneficiary enrollment in the Prescription Drug Low Income Subsidy Program (LIS), the Medicare Savings Program (MSP) and in general rural outreach and enrollment efforts for Medicare Part D. Senior Advocacy Services (SAS) was awarded the contract through a competitive RFP process and will operate the HICAP program in 2009-2010.

Requested Board Action:

Authorize the Director of Human Services or designee to sign and execute Standard Agreement MI-0910-27 with the California Department of Aging for FY 2009-10 in the amount of \$23,638 and to amend the Agreement, provided amendments do not increase the total county cost and do not substantially change the scope of the work.
