Prior Board Action(s): 8/4/09 – Approved Resolution No. 09-0709 revising schedule of parking fines. 8/31/93 – Approved Resolution No. 93-1309 for the City and County Parking Consortium’s Parking Administrative Adjudication Policy and Procedure Guidelines. 6/22/93 – Approved Resolution No. 93-0877, authorizing General Services to process and adjudicate parking citations and establish parking citation fines, fees and surcharges in accordance with AB 408.

Alternatives - Results of Non-Approval: Regional Parks would be unable to issue citations for non-payment of day use or overnight fees at county parks.

Background:

On August 4, 2009, the board adopted Resolution No. 09-0709 to revise the schedule of parking fines and penalties for the County of Sonoma. The schedule contained a reference to Code No. SCO 20-38 for "Non-payment of Overnight Fee" and "Non-payment of "Day Use" Fee. This code section only refers to Bodega Bay & Doran Parks. The County of Sonoma has over 40 Regional Parks that require the payment of day use fees and several that require the payment of overnight fees. SCO 20-24 provides a more accurate description of the violations and will allow County Parks to cite vehicles that have not paid the appropriate fees for use of the facilities at all County park locations.
