Alternatives – Results of Non-Approval:

Non-approval or delay of appointment could result in the inability of the Workforce Investment Board to meet deadlines for required activities under the Workforce Investment Act.

Background:

A copy of the proposed membership for the Youth Education & Employment Services Council is on file with the Clerk of the Board.

The Board of Supervisors is requested to adopt a resolution appointing Steve Freitas, Windsor Chief of Police, to the Youth Education & Employment Services Council. Mr. Freitas would fill a seat for law enforcement.

The Workforce Investment Act (WIA) regulations established that the Sonoma County Workforce Investment Board (WIB) and its Youth Education & Employment Services Council would serve as policy oversight bodies for its employment and training programs. The law requires that appointments to these bodies be made by local elected officials. In accordance with the established written agreement between the Sonoma County Board of Supervisors and the WIB, the WIB reviews and approves candidates' applications for membership and forwards its recommendations to the Board of Supervisors for final approval and appointment. Members are not appointed by supervisorial district, but on a county-wide basis.

Recommendation:

The Workforce Investment Board recommends that the Board of Supervisors approve the resolution appointing Steve Freitas to the Youth Education & Employment Services Council.
