WHEREAS, the Human Resources Director has determined the new classification of Senior Lactation Consultant will be assigned to the Engineers and Scientists Health Professional Bargaining Unit 0075; and

WHEREAS, the County and ESC, IFPTE Local 20 met and conferred on the issue of salary for the new job classification represented by ESC, IFPTE Local 20 in accordance with Government Code 3500, resulting in a signed Letter of Understanding establishing the salary for Senior Lactation Consultant; and

WHEREAS, the Human Resources Director and the County Administrator recommend establishing the salary for the new job classification of Senior Lactation Consultant at salary range 3043; and

WHEREAS, the Senior Lactation Consultant is a non-exempt classification in accordance with the Fair Labor Standards Act.
