

## Welcome to Sonoma County Regional Parks Campgrounds

### Campground Registration

- A. **Campsites may be subject to reservation.** To reserve, call (707) 565-CAMP (2267) or go online to [www.sonoma-county.org/camping](http://www.sonoma-county.org/camping). A non-refundable reservation fee per site, in addition to the camping fees, will be collected at time of booking. Any sites not reserved may be occupied on a first come, first served basis.
- B. **Check campground status board!** Register with park staff on patrol, or at the staffed entry station. **Don't forget the campsite # & vehicle license plate(s).**
- C. Staff may leave a courtesy envelope if fees have not been paid. There is an additional charge for extra vehicles and dogs. Please pay promptly upon receipt at the designated drop slot.
- D. Individual campsites accommodate up to 8 people and camping fee includes entry for one vehicle. Towed vehicles/trailers are free.
- E. Group campsites accommodate groups of 25-75 at Spring Lake Park and 25-50 at Doran Park. Group camping fee includes entry for up to 15 vehicles. **NO RVs.**
- F. Firewood can be purchased from park staff, the staffed entry station or at the Camp Host site.
- G. Be sure to make your site look occupied at all times. Do not leave anything of value unattended.
- H. You may camp for ten consecutive nights at a time; maximum stay per campground is 30 nights in a calendar year. Limits at Spring Lake Park are 10 days in the summer, and 10 days in the winter.
- I. Certain campsites will be posted as tent camping only.
- J. Cash and pre-printed checks with current photo ID will be accepted.
- K. No "saving" of sites is allowed. A trailer must be registered to the same site as the vehicle that towed it.
- L. A maximum of two vehicles (autos and travel, boat or utility trailers) may be parked at most individual campsites.

#### ATTENTION: WILDLIFE PROBLEM

**Please do not feed the wildlife!** Wildlife becomes dependent on humans when fed. Store food in secure containers or in your vehicle. Please close dumpster lids, trashcans and restroom doors. **Thank you.**

## You are responsible for knowing park rules and regulations.

### CAMPING REGULATIONS

- 1. Remember to check campground status board for site information.
- 2. Check out time is noon.
- 3. Coin operated showers are available.
- 4. Camping is allowed in designated sites only. No 'overflow' facilities are available.
- 5. Camping fees will be charged for any occupancy of the campsite regardless of the length of stay.
- 6. Juveniles (under 18 years of age) must either be accompanied by sufficient, competent adult leadership or have written parental consent and an emergency phone number to camp.
- 7. Vehicles, trailers, motorcycles, boat trailers and wheels of any kind are restricted to designated roadways, parking areas and/or pavement.
- 8. Obey the posted speed limit in the campgrounds. Traffic regulations are enforced. All drivers and vehicles must be licensed.
- 9. Fires are permitted only in the fire rings provided. Barbecues may be used on a cleared area in the immediate vicinity of the campsite or day use picnic tables. Fires are not allowed on the beach.
- 10. Collection of firewood is prohibited.
- 11. Quiet hours are from 10 PM to 7 AM. Generators or loud music that disturb other campers will not be permitted at any hour.
- 12. All pets must be securely leashed (no longer than 6 feet) and under the control of a person at all times, or contained within a vehicle or tent. No pet shall be unattended in any campsite. Persons with noisy or vicious animals will be required to leave the park. Pet owners must clean up after their pets immediately. All dogs 6 months and older must have proof of rabies inoculation or current license. Pets are not allowed at the Spring Lake Park swimming lagoon area.
- 13. Wastewater, or gray water, must be contained and disposed of only at the RV sanitation station.
- 14. Utilities, or hook-ups of any kind, are not provided. Hooking up to water faucets longer than is necessary to fill a RV tank is prohibited.
- 15. Day use parking and picnic facilities are not available at campsites. Sites are for registered campers and their guests only.
- 16. Boat washing and fish cleaning at designated stations only.
- 17. Place garbage in trash bins, NOT FIRE RINGS.
- 18. Recycling containers are available throughout the parks.
- 19. Nails, tacks, etc., may not be attached to trees or park structures.
- 20. Day use visitors to the campground must purchase a parking permit. Park day use areas close to everyone (including campers) at sunset.
- 21. At Stillwater Cove, campfires are not allowed during posted Red Flag Days.
